GP: how/where to include - F2F clear inputs.

- 1- GP: document structure to modify / include ADE/ADR portions?
 - Sections 2.2 and beyond are OpenHAN centric at this point.
- OpenADE (Zahra) interface issues

OpenADR is mainly server description for DR and Price events; this is outside of Edge; concentrate on receiving side (edge). Conformity wrt OpenADR is not Edge issue per se. Edge conformity should concentrate on edge devices.

Addressing issue of "conformity" for OpenADR and OpenADE: somewhere receiver

side conformance needs to be addressed. Need more input from respective experts.

NIST (Zahra): CIM will be used as basis for OpenADR/ADE/HAN. Extensions to CIM will be proposed via IEC, TC 57 WG 14. Enterprise Conformance shall address conformity w/ CIM.

CIM and Generic Architecture topic remains wrt OpenADR/ADE/HAN and CIM, and under what conceptual framework are we going to consider the issue of conformity----that which covers all relevant elements of the required architecture.
