Summary

Erich Gunther of EnerNex opened the session with a presentation on new use case development. The presentation included the UtilityAMI 2008 SRS and then lead into the work plan discussion.

Technical Discussion

Details of the discussion relating to new use cases follows:

- Decision last time to develop new use cases
 - Shelley Moister (L&G) Use the HAN SRS to match up what the perceived market requirements would be. It's a very comprehensive document and accurately reflects the requirements of 1.0. Would look for the exception side of those requirements as a next step for refinement.
 - (unidentified person) Deployment guidelines/details/scenarios
 - o Zahra Makoui Bring in the home-to-grid venders (consumer electronics) to participate
 - (unidentified person) Utility requirements for plug in vehicle integration and distributed generation.
 - o (unidentified person) Add road mapping to identify vision of what future visions might include. What are the next two or three things the industry will face?
 - Dan Rogier Focusing on the support of the HAN equipment after deployment. There will be a multitude of actors who will support and maintain the equipment after it is deployed in the home.
 - o Chris Knudsen Dependencies for control. Restrictions for load management.
- Use Cases Proposed in 2008
 - Matt Gilmore At this point, we need to map HAN requirements into the security (AMI-Sec) space
 - Craig Rodine (Grid Net) Don't see DER as one of the things in the home environment that we could look at.
 - Larry Kohrmann (Oncor) We have received some requests from Australia for water use cases
 - o Erich Gunther What do we need to tackle first?
 - Darren Highfill Multiple Dwelling Units (MDU)
 - Doug Houseman There are two MDU scenarios. One is master metered and the other is a high density installation.

- Master Metered Issues
 - Doug Houseman How do you separate things? How do you track things? Really nasty with staged aged homes.
- High Density Case Issues
 - Doug Houseman Dweller may not hold the bill (i.e. not know what service they are signed up for)
 - > Darren Highfill Is physical separation an issue that needs to be addressed?
 - Doug Houseman Intermediate floor transformers. How do you make sure you get the right information to the end customer?
 - > Darren Highfill What about meters which are not readily accessible?
 - Matt Gilmore How do you make sure the devices which should have joined did and the ones that should not have joined did not.
 - ➤ Erich collected group thoughts online in the PowerPoint presentation. These were focused on "Range Extension", "Interference Mitigation", and "Nomadic HAN Device".

Erich posed the question to the group on if there was a need to get together to work on these new use cases? The majority of the group indicated yes. Erich indicated that a utility volunteer was needed to lead this particular effort and that a group of folks who are going to work on the identified use cases identified. Wayne Longcore volunteered Brad Singletary of EnerNex (on Consumers Energy behalf) as the utility lead. Volunteers for this effort were as follows:
