 - AMI Security Profile Version 1.9 passed the vote; now awaiting OpenSG TC approval and version 2.0 designation; Will be sent to Annabelle upon OpenSG TC approval
 - ii. Usability Analysis (3PDA SP review) John Lilley and Daniel Thanos are working on charter – look to have completed by June 28th and will review 3PDA when charter is established. The group needs a secretary. The group is seeking to establish a distribution list – please send participation interest to John or Darren.
 - iii. CyberSec-Interop Brian Smith / John Stuart (v-chair) / David Tummim (chair) voted at face-to-face to start this group. Looking to get organized by face-to-face. If interested in joining send email to <u>Dave431@enter.net</u>.
 - iv. Network Security Slade Griffin and Vincent Bremmel are seeking to start subgroup to cover network security.
 - c. SG Network support evaluating messaging payloads and interfaces; used NIST network architecture and drilled down another level deeper. Work to feed into SGIP PAP2. SG security's review of the confidentiality, integrity and availability ranking were not considered in SGIP PAP2 work due to time constraints. Darren working with Ron Cunningham/AEP. Only have about 800 message payloads review and has expanded to 1500 payloads.

d. OpenHAN support – The group is working toward a 2.0 specification. The group has reviewed current language in the document and provided comments. The group is now evaluating detailed work. SG Security members are mapping requirements; Slade Griffin and Brad Singletary are working with Mary Zientara (OpenHAN Chair) on security integrity in the next round.

3. New Business

- a. Sub-groups do not currently have a self-serve mailing list capability. This is being evaluated.
- b. Agenda items for F2F
 - i. Suggestions on threats (insider)/Slade, vulnerabilities, and risk (assessment).
 - ii. **ACTION ITEM**: John and Darren to discuss upstream / downstream risk assessment.
 - iii. ACTION ITEM: Darren to follow up on NERC CIP for face-to-face (Scot Mix)
- 4. External Engagements, Business, & Issues
 - a. CSWG The comment period on second period has closed. The NIST CSWG is reviewing comments and resolving comments. If there are still comments that people would like to submit, then the CSWG will continue to accept over the next few days. Chapters of the document are being rearranged. NIST management will receive the revised NIST-IR about the 3rd week in July for review and is planned for public release in August.
 - b. NERC CIP revisions The NERC CIPs as ratified and applied to the industry now has undergone 3 revisions. This effort started when approved to FERC with certain provisions; broken down into stages. The 4th revision of the CIPs is by far the most comprehensive revision and is a complete restructure how they address cyber critical assets, etc. The current CIPs are audit-centric, whereas the latest release is more of a risk-based approach and addresses the measures needed in order to protect assets. There is a lot of controversy and discussion around the latest version. The informal comment period has closed. 900 comments were received from 119 different sources. The drafting team are currently reviewing these comments and resolving to produce a draft for vote within the next couple of months.
