Summary

The team discussed AMI System Security Requirement (SSR) revisions, the AMI-SEC SSR press release, AMI Component Catalog, and a potential opportunity to work with the National SCADA Test Bed.

Documents

Technical Discussion

AMI-SEC SSR Revisions

Bobby Brown discussed the AMI SSR revisions requested by some utilities. Revisions include:

- Changed the title back to AMI System Security Requirements (dropped the "and Guidelines")
- Added a paragraph to include acknowledgements to sources that requirements were derived from
- Cleaned up incomplete wording in section A.5
- Included "Supplemental Material: " in the Appendix B title
- Added an introduction paragraph to Appendix B stating what it is and its relationship to the requirements
- Changed the footer of Appendix B to have independent numbering and removed the document title

The group discussed other changes to be made before re-release that include:

- Releasing revised document to version 1.01
- Spelling out "SFR" (Security Functional Requirement)

AMI-SEC SSR Press Release

The chair discussed revisions to the press release. The release has been edited to cast utilities in a proactive light. After discussions and recommendations from utilities and ASAP, recommendation has been made to only release an AMI-SEC press release and not an additional ASAP press release. The chair advised that if there is no additional feedback from the group, then it will be assumed that the current document is ready for public release.

AMI Component Catalog

The Chair discussed the need to socialize the AMI Component Catalog hosted on the SmartGridipedia.org website. The team reviewed and discussed the purpose and use of the catalog. Components are to be abstract, vendor non-specific security components that fulfill a need in the SSR and provide security mechanisms. One of the key values is in offering utilities a means of evaluating products. Vendors have an opportunity to build reference to the requirements and security mechanisms their product addresses.

NSTB Opportunity

The Chair presented information on the possibility to have an opportunity to collaborate on a network intrusion detection correlation project with the NSTB. This concept has generated a lot of technical and other discussions, but understanding utility's requirements in this domain needs to be attained in order drive work forward.
